## MEMBER RECOGNITION

### In Memoriam

#### Deborah E. Powell, MD, PhD (1939-2025)

Dr. Powell was a [member](#) of the [Senior Fellows Group](#) (SFG) and served as the SFG Executive Committee's inaugural Vice Chair from 2017-2021. She served initially as a Chair at the Department of Pathology and Laboratory Medicine at the University of Kentucky from 1988-1997, and became the AAPath (APC at the time) President-Elect from 1996-1998, before rising into Dean roles first at the University of Kansas (1997-2002) then at the University of Minnesota, where she served as the Director of Pathology Education in the [Department of Laboratory Medicine and Pathology from 2012-2021](#). Most recently, Dr. Powell was a founding member of the AAPath's [Academy of Distinguished Pathology Educators](#) and was actively serving as the Chair of the Academy's Board. Dr. Powell was a donor to the [Society of '67](#), AAPath's philanthropic arm to support programs that foster the development of academic pathology and future leaders in academic practice, education, and research. She was also a role model and mentor to countless physicians and students, as well as an active member of AAPath's UME Committee, Senior Advisor to *Academic Pathology* (AAPath's journal), frequent connector to organizational leaders and medical education speakers in the annual meeting program, and always available to serve in any capacity that supported the AAPath. 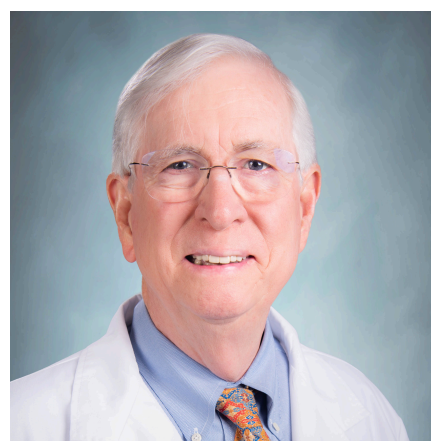

## ADVOCACY UPDATE

### Advocacy Update

*From the desk of AAPath's Deputy Director, [Lydia P. Howell, MD](#)*

The big news this month is the end of the government shutdown which will bring more opportunities for advocacy for academic pathology. Note that the minibus appropriations package signed by President Trump included funding for the Department of Veterans Affairs which maintains the Medical and Prosthetic Research program at the FY 2025 level of \$945 million. For details on the NIH re-opening, be sure to check out the NIH's [Interim Guidance on Reopening of NIH Extramural Activities](#).

On November 17<sup>th</sup>, AAPath joined several other organizations as a signatory on a [letter](#) asking the Center for Medicare and Medicaid Services (CMS) to continue to allow provision for remote digital cytopathology review as previously allowed during the COVID-19 pandemic. This [provision](#) is scheduled to end in six months. CMS has already extended this practice for surgical pathology.



CLIA regulations first established in the late 1980s require that pathologists are on-site with cytotechnologists when reviewing and issuing reports and creates unique challenges for the practice of cytopathology. AAPath supports the letter since digital pathology, including remote review, is the future of practice for our trainees and because limiting these services will adversely affect access and patient care in rural and other underserved areas. It is our hope that the joint letter from multiple organizations will raise awareness that regulations need to be updated by CMS or another responsible agency in order to reflect contemporary practice and health care needs. The letter was initiated by the Association for Pathology Informatics (API).

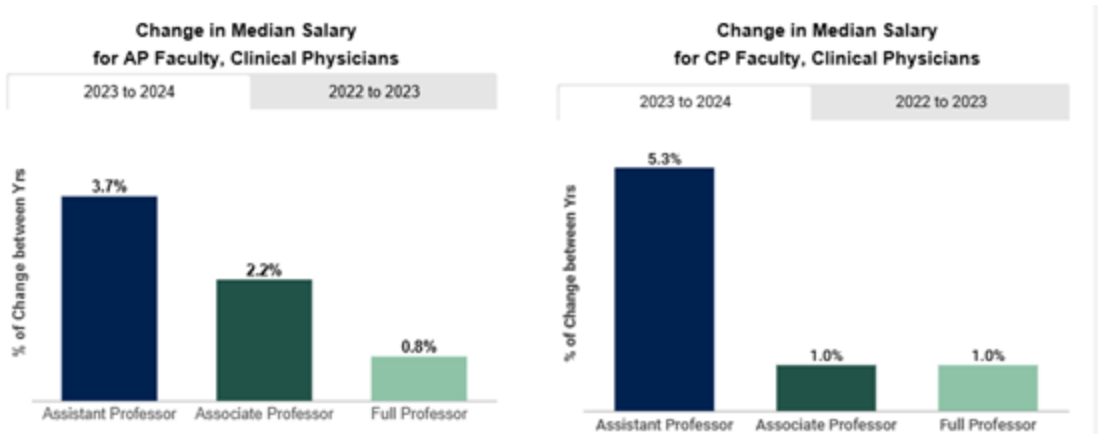
Finally, our friends at the Association for Molecular Pathology (**AMP**) are seeking support from **our members in opposing the [Patent Eligibility Restoration Act](#) (PERA)**. If passed, human and non-human genetic sequences will be patentable under PERA, overturning critical Supreme Court decisions including the *Association for Molecular Pathology v. Myriad Genetics Inc*, *AMP vs. Prometheus Laboratories*, and more. **Specifically, AMP asks that you communicate concerns with the offices of** Senate Judiciary Committee Chair Chuck Grassley (R-IA) and Ranking Member Adam Schiff (D-CA) who are taking a thoughtful approach to evaluating this legislation.

**AAPath 2025 Compensation Benchmarking Study Now Open!**

For insights on how to submit academic pathology compensation data and how to leverage this specialty data in conversations with hospital and medical center executives, even when your institution uses other national benchmarks, like MGMA and AAMC, replay the recorded webinar from October 30<sup>th</sup>. The webinar on the AAPath Compensation Benchmarking Survey was produced by the Practice & Management Committee with APEX Council members and is accessible through the Past Virtual Events page: [www.academicpathology.org/past-virtual-events](http://www.academicpathology.org/past-virtual-events) (member login required).

Key take-aways on completing the data:

- Plan ahead – block dedicated time
- Build once, re-use yearly – pull data from previous collection year (if participated in the past) and update accordingly
- Delegate wisely – export the form to an Excel spreadsheet, then segment components to share with your relevant admin team members for completion, then compile and submit data
- Leverage your network – connect within your community of Chair and/or APEX membership
- Prioritize data quality over quantity

The [AAPath Compensation Benchmarking Survey](#) addresses a critical need for member departments to access comparative regional and national data that informs recruitment, retention, and discussions with institutional leadership. The annual survey platform is designed to confidentially collect data from participating departments and transform into a member-interrogated reporting system when the data collection period is closed. **For participating departments that complete the required questions (to be eligible to access data)**, the anonymized and aggregated results are accessible and sortable by a variety of self-selected metrics for analysis.

The strength of the data is only as good as the participation level of the AAPath membership, so please make the time to submit your departmental data! **The 2025 data collection period is now open through March 2026.** To make participation in the 2025 study easier, no new questions will be added and, if you participated previously, data may be quickly copied from the previous year. Chairs and APEX members with data entry privileges have received an email alert with instructions from Dynamic Benchmarking, or you may go directly to [start data entry here](#). For those departments who have participated in the past, access up to three years of data and customize reports to your precise needs.
