This Chair will guide and implement a strategy of innovation and advancement of pathology and laboratory services and scholarly activity while enhancing the research and educational programs within a nationally recognized health system and medical school.

The School of Medicine (SOM) is among the nation's leading medical schools, consistently ranked by *U.S. News & World Report* for this excellence. The Institution excels in scientific discovery, with a research-funding portfolio of over 1,300 active awards with more than \$390 million of NIH funding. As the clinical engine, UC Davis Health (UCDH) is a multi-billion-dollar health system within the University of California System, which includes the 646-bed academic medical center, 32 ambulatory sites, a 1,000-member medical group and an NCI-Designated Comprehensive Cancer Center.

The Department of Pathology is comprised of over 40 faculty and 400 staff who provide comprehensive anatomic and clinical pathology services across 20 subspecialties. A clinical and/or research focus in cancer is desired but is not required.
